主旨：檢送澳大利亞預告修正十字花科甘藍等4種種植用種子輸入檢疫條件案，請查照。

說明：

- 一、依據WTO/SPS 107年2月27日G/SPS/N/AUS/445號通知文件(附件)辦理。
- 二、澳方評估認為*Colletotrichum higginsianum* (十字花科蔬菜炭疽病菌)及*Fusarium oxysporum* f. sp. *raphani* (蘿蔔黃葉病菌)隨甘藍 (*Brassica oleracea*)、油菜 (*Brassica rapa*)、芝麻菜 (*Eruca vesicaria*)及蘿蔔 (*Rhaphanus sativus*)種子傳入澳國之風險高，並預告新增相關檢疫措施；該些種子須於輸澳前或輸澳後以廣效型系統性殺真菌劑處理，其中於輸出前處理者，應由輸出國於植物檢疫證明書上加註證明。
- 三、旨揭檢疫條件將於澳方正式公告實施時，另函通知。

| <b>6. Description of content:</b> Acknowledging the change in risk profile, the department is undertaking an extensive review of the existing import conditions for vegetable seeds, including those for brassicaceous crops. The review identified two fungal pests, associated with the seeds of several brassicaceous crops, as meeting the International Plant Protection Convention (IPPC) criteria for a quarantine pest. The identified quarantine pests are <i>Colletotrichum higginsianum</i> and <i>Fusarium oxysporum</i> f. sp. <i>raphani</i> . The unrestricted risks of these quarantine pests do not achieve the appropriate level of protection (ALOP) for Australia.<br><br>This review evaluated the effectiveness of existing risk management measures for the identified quarantine pests, and proposes additional mandatory phytosanitary measures to reduce the risk of their introduction into Australia. Standard requirements for the importation of seeds for sowing apply to all brassicaceous seeds. The department proposes additional phytosanitary measures for seeds of <i>Brassica oleracea</i> , <i>Brassica rapa</i> , <i>Eruca vesicaria</i> and <i>Raphanus sativus</i> . The proposed additional phytosanitary measures require:<br>– Mandatory fungicidal treatment (off-shore or on-shore) for seeds of <i>Brassica oleracea</i> , <i>Brassica rapa</i> , <i>Eruca vesicaria</i> and <i>Raphanus sativus</i> as specified in this review;<br>– Seed lots treated off-shore to be accompanied by an official government Phytosanitary Certificate endorsed with the additional declaration that the consignment has undergone mandatory treatment in accordance with Australian import conditions. |
